## Corporate Pass Criteria

- 1) Passes can be used by the business owner, employees, customers and guests 7 days a week without restriction.
- 2) Tee times are required. Please call the ProShop 802-885-1010 option 1 or book online prior to your round.
- 3) For an 18 hole round, provide two passes for payment.
- 4) If cart passes are not purchased, the golfer can choose to walk or pay the cart fee at the time of the round.
- 5) Payment must be made by corporate check or credit card.
- 6) Passes are not transferrable and can only be sold with a lodging (stay and play) package. They expire October 31, 2020.

Dress Code: Standard golf attire preferred - jeans permitted; no tank tops, cutoffs or short shorts.
