Corporate Membership Criteria

- 1) Must purchase minimum of 3 memberships. Every 3rd membership includes one guest membership. If the business has only two employees, one guest membership can be substituted for a membership.

For example (note examples do not include sales tax):

\$1,800 - Two employees and two guest memberships (one guest is paid membership)

\$1,800 - Three employees and one guest membership

\$3,600 - Five employees, three guest memberships (one guest is a paid membership)

\$3,600 - Six employees, two guest memberships

Note: Prices increase to the 2021 rate after 10/31/2021

- 2) Employee's names must be listed on the application to qualify for Membership privileges, see below. Any named employee can bring the number of guests the plan allows, see examples above. Guest must be accompanied by named corporate member.
- 3) Tee times are required and can be made up to 7 Days in advance.
- 4) Trail Fee can be added to a membership, includes unlimited use of a club cart. Trail fee is specific to an employee and is not to be shared with the group. Guest of an employee with Trail Fee privileges rides for free.
- 5) Payment must be made by corporate check or credit card. It is recommended that a corporate credit card be placed on file to collect cart fees.

Membership - includes unlimited play, 7-day tee times, and access to tournaments, children 17 and under play for free when accompanied by the member. Amenities at additional cost when available. If required, membership is subject to assessments.

Dress Code: Standard golf attire preferred - jeans permitted; no tank tops, cutoffs or short shorts.
